A Government Servant in BS-19 (Rs.31,000-1600-63,000/-) was drawing @ 20 Q.1. Rs.59,800/- on 1.12.2013. He remained under suspension from 15.12.2013 to 31.03.2014 followed by reinstatement. He availed extra ordinary leave from 15.04.2014 to 31.03.2015. He retired on superannuation. His date of birth is 30.09.1956. He joined service on 01.09.1980 on Rs.40,155-2075-81,655 and on 1.7.2016 his salary was Rs 49,370-2560-100,570.

Calculate Pension Emoluments, Net Qualifying Service, Gross & Net Pension and Commutation.

Q.2. Comment on the follwoing:

- While maintaining priced inventory of stores, the Authority decided to add 05 40% cost over market value of stock articles with a view to have reasonable profit and to cover departmental charges.
- A Government Employee got Retiring Pension w.e.f 01.02.2017. His pension 05 sanction was issued on 02.04.2017 and pension was started from the date of sanction.
- Punjab Government Servant proceeded on Foreign Service wherein the 05 employer did not agree to pay pension contribution.
- A Provincial Government Servant was transferred from Multan to Lahore 05 where he was availing 80 days leave on full pay. No joining time was allowed to him.
- A Government Servant in BS-17 on his repatriation from deputation 05 confronted disability because of the duty rendered during Foreign Service. A claim amounting to Rs.375,000/- for reimbursement of medical expense incurred on his recovery was forwarded to borrowing department.
- Head of the department BS-20 was competent to accord sanction of 05 development expenditure upto Rs.5.00 million. A BS-19 officer accorded approval of development expenditure for Rs.4.75 million during look after arrangement in consequence of leave of Head of Department for 4 days.
- Audit pointed out recovery of Rs.150,000/- from the last six months pay bill 05 of a Government Servant. The Competent Authority waived off recovery.
- The Competent Authority curtailed joining time of a Government Servant by 05 3 days on his transfer from Multan to Lahore.
