The students are advised to show their PIPFA Registration Card (in original) at the time of registration at the Computer Institute and also attach an attested copy along with the CBE Registration Form. The verification and stamp of PIPFA Centers / Approved Coaching Centers on CBE Registration Form is a must (For first time appearance only).

Students are advised to submit the CBE Fee through <u>Pay Order</u> only in favor of PIPFA, at any PIPFA approved CBE Centers; Cash payment will not be accepted.

The CBE (Level-1 & 2) will be held from March 02nd, 2020, tentatively. The schedule of CBE will be communicated in due course of time. The students are advised to be in contact with PIPFA Head Office or visit www.pipfa.org.pk for confirmed schedule of CBE Quarterly Summer - 2020.

As per PIPFA Career Plan, the number of papers required to conduct a CBE at any center is at least 10. In case of less number of papers students will be transferred to other CBE center of their desire.
