## Students are advised to deposit CBE Fee in any branch of Faysal Bank in Account No. <u>0131007900226627</u> only in favor of PIPFA; Cash payment will not be accepted.

The CBE (Level-1 & 2) are tentatively scheduled from March 02<sup>nd</sup>, 2021. The confirmed schedule of CBE will be communicated in due course of time. The students intend to enroll in Quarterly Computer Based Examinations Summer-2021 may opt to Remote Access Examinations or Physical Lab Based Examinations as per their convenience.

As per PIPFA Career Plan, the number of papers required to conduct a CBE at any venue is at least 10. In case of less number of papers, students will be transferred to other CBE venue of their desire.
